



Workshop on: *Assessing unfair inequality using register data*

This workshop brings together international researchers to discuss available data and innovative measurement methods for assessing intergenerational persistence of advantage and to evaluate the implications of large education reforms on it. The workshop blends empirical contributions, based on a representative, longitudinal dataset issued from the Swedish Intergenerational Register (covering 30% of the population), with theoretical contributions that are related to the measurement of unfair inequality.

The workshop is open to all personnel and students of the University and no registration is requested. Master students, PhD students and junior researchers who are curious about Swedish register data, what they offer and how they can be used in inequality and policy evaluation analysis, are strongly encouraged to attend.

Speakers

- **Francesco Andreoli** is Associate Professor of Economic Policy at the University of Verona and Research Scientist at LISER. His research interests are on public economics, more precisely on distributional issues (inequality between generations and across space) and on the role of public policy in alleviating inequality (childcare, educational and redistribution policies). His research has received financial support from the FNR (Luxembourg), the ANR (France) and the European Commission (NORFACE ERA-NET) and has appeared, among others, in *The Review of Economics and Statistics*, *Social Choice and Welfare*, and the *Journal of Business & Economic Statistics*.
- **Nicolas Gravel** is professor at the Aix-Marseille University (after October 2002). He interrupted on two occasions (2004 -2007 and 2017-2021) his professorship at Aix-Marseille University through a deputation at the French Ministry of foreign affairs where he served respectively as research fellow at, and as director of, CSH. Nicolas Gravel's main field of expertise is public economics. His recent research themes include the measurement of inequalities, poverty, and social mobility, the analysis of processes of human group formation, tax competition, contribution to public good and decision under uncertainty. He has published more than fifty research articles on these themes in various journals, including the *American Economic Review*, *International Economic Review*, *Journal of Mathematical Economics*, *Games and Economic Behavior*, *Journal of Public Economics*, *Economic theory*, *Journal of Economic Theory*, and *Social Choice and Welfare*.
- **Markus Jäntti** is Professor at SOFI, Stockholm University. He has been scientific director of the Luxembourg Income Study His research centers on income and wealth inequality and poverty and socio-economic mobility, especially in a cross-national perspective. His research features on the *American Economic Review*, *the Journal of European Economic Association*, *Social Choice and Welfare*, *Journal of Public Economics*.
- **Arnaud Lefranc** is Professor of Economics at CY Cergy Paris Université, France, where he also served as Vice-Rector for Research Development (2017-2022). He holds a PhD from Ecole des Hautes Etudes en Sciences Sociales and held visiting positions at Princeton University, the European University Institute and Doshisha University (Japan). His research interests focus are in the fields of public, labor and family economics, with special emphasis on inequality of opportunity, intergenerational mobility and educational policy. His research was supported by the ANR, the IUF, the FP7 NORFACE ERA-NET and the Russel Sage Foundation (USA) and was published in high-quality international journals including the *Review of Economics and Statistics*, the *Review of Income and Wealth*, the *Journal of Population Economics* or the *Journal of Public Economics*.
- **Claudio Zoli** is professor of Public Finance at Verona University. He is member of the editorial board of the *Journal of Economic Inequality* and of the *Review of Income and Wealth* and has been secretary and member of the Executive Committee of the International Scientific Association ECINEQ the Society for the Study of Economic Inequality. His research interests include inequality and distributive analysis, redistributive policies and taxation, theory of choices under risk, intertemporal evaluations and evaluation of social risk and analysis of social conflict. Further research and teaching interests involve auction theory with applications to public procurement.
